1. **OPENING ITEMS**

A. <u>Call to Order</u>:

A SPECIAL Public Board Meeting of the Santa Cruz County Provisional Community College District Governing Board was called to order on Tuesday, June 15, 2021 at 4:00 p.m. by Dr. Angela Meixell, Chairperson.

2. STANDING REPORTS AND ACTION ITEMS

A. Public Hearing 2021-2022 Budget

- Dr. Meixell said that Pursuant to A.R.S. § 15-1461, the Governing Board shall hold a public hearing and present the proposed budget to the persons attending the hearing;
- She added that the public will acquire one hour for comments, concerns, etc.
- Mrs. Tavera provided each Board Member with two packages and addressed the following:
 - Schedule A, B, and C Template per the State of Arizona; the sum of the formulas is based on the first ones
 - The Expenditure Limitation is at \$1,441,943;

- She also said they are still in conversation with the auditors regarding outside expenditure limitation, but nothing has been approved yet;
- Mrs. Tavera said the budget numbers were exactly the same as presented during the last board meeting; this is how it was presented to the Public and will be adopted as such;
- Other useful pages she included were the schedules and the calendar;
- The newspaper has published the budget;
- Ms. Collier thanked Mrs. Tavera for a job well done;
- Dr. Varona said they needed to work on the contingency;
- Ms. Collier said it will depend on the final auditor's conversation;
- Dr. Varona reminded Mrs. Tavera about the ASBA 45th Annual Law Conference scheduled in September at the JW Marriott Camelback Inn; he asked to reserve rooms and to register those interested to attend the conference;
- Again, the public had the opportunity to address the Governing Board during this time;

Ms. Collier motioned to adopt the SCCPCCD FY 2021-2022 Budget. This motion was seconded by Mr. Fanning. Motion carried unanimously, 4-0. Note: Dr. Varona said for people to take note of the taxes dropping 2 cents;
