• Call to Order / Pledge of Allegiance

The Santa Cruz County Provisional Community College District Governing Board Special Study Session was called to order at 9:13 a.m. by Dr. Angela Meixell, Chairperson.

Dr. Marcelino Varona, Jr.-Board Member, and Mr. Victor Fontes, Board Member were not in attendance. Mr. Nils Urman-Board Member, joined the meeting at approximately 9:55 a.m.

1. OPENING REMARKS BOARD PRESIDENT

- a) Dr. Meixell welcomed everyone in attendance and stated that the order of the agenda was rearranged, moving the Open Meeting Law 101 Presentation to the first item;
- **b)** Dr. Meixell introduced Mr. Jack Lunsford, President of The Lunsford Group, and said he was asked to teach the basics of the Open Meeting Law 101.

- **xi**) He concluded his presentation by providing the Board Members with informational items and an example of an agenda template from the Maricopa County that staff will be able to use and cut/paste easily.
